Subject: Regarding - Revamping the Civil Defence in the State.

Sir,

I am directed to refer to the subject cited above and to say that Himachal Pradesh State Disaster Management Authority (HPSDMA), DM Cell, Department of Revenue had launched a Scheme on Creation of Task Force of Youth Volunteers for "Better Disaster Preparedness and Response in the State" (copy enclosed). A structure like Civil Defence is required to man the volunteer's cadre. The proposed structure will be able to man the volunteers who will be raised for disaster management in the State. Except for training and capacity building of the volunteers and keeping their database, no other expenses will be spent to create this structure in the State. However, creating the proposed structure will significantly enhance the disaster management capacity of the State at the grass root level also.

In view of the above, an agenda for revamping of the Civil Defence in the State was placed during the 9th meeting of State Executive Committee (SEC) held on 29 May 2019 constituted under the Disaster Management Act 2005 chaired by the worthy Chief Secretary, Himachal Pradesh for consideration and approval. The SEC considered and approved the agenda for revamping of Civil Defence in the State.

This is for your information that Home Department has already vide its Notification No. 14-7/64-Home (B) dated 28.01.1975 (Copy enclosed) has already declared the District Magistrates as Civil Defence Controllers and the Commandants, Home Guards as Deputy Controllers, Civil Defence.

Recently the Home Department has issued following two notifications in pursuance to the liaison of the SEC dated 29/05/2019 :

1. Empowering Sub-Divisional Magistrate of a Sub-Division to exercise the powers of enrolment of members of Civil Defence in the Sub-Division vide Notification No. Home-F(A)1-1/2019 dated 22-10-2019 (copies enclosed).

2. Appointing the Pradhan of the Gram Panchayat as the Warden of Civil Defence in that Gram Panchayat vide Notification No. Home-F(A)1-1/2019 dated 22-10-2019.

You are, therefore, requested to institutionalise and utilize this structure to create a system for disaster response in the State as envisaged. You are also requested to bring this arrangement to the notice of all concerned.
