- Review physical and financial progress of all GLOF mitigation components at regular intervals.
- Ensure technical vetting and quality assurance of studies, models, surveys, and structural interventions.
- Oversee installation and operationalization of Early Warning Systems (EWS) and monitoring networks.
- Guide implementation of hazard modelling, glacier/lake monitoring, and vulnerability assessments.
- Facilitate engagement of domain experts, research institutions, or additional specialized agencies when needed.
- Ensure adherence to programme guidelines issued by NDMA/CWC/Gol.

- Address implementation challenges and recommend corrective actions.
- Review and endorse reports, documents, and submissions to be forwarded to NDMA/MHA/CWC.
