Prabodh Sexena, Chief Secretary-cum- Chairman State Executive Committee, Himachal Pradesh.

At the outset, the Additional Chief Secretary (Revenue) to the Government of Himachal Pradesh, Sh. 5. The SEC was apprised that various proposals were received from different Departments and Districts for consideration under the Preparedness & Capacity Building Fund of the SDRF. The following proposals have been recommended by the Sub-Committee constituted as per the guidelines for the constitution and administration of the Preparedness and Capacity Building funding window under the chairmanship of Additional Chief Secretary (Revenue), as detailed below:

6. Proceedings of the Sub Committee dated 6th August 2025 placed at annexure was seen. The DMC has an amount of Rs. 90.24 Cr available under P&CB window out of which 20.92 Cr has been released and Rs. 41.56 Cr is still available for utilisation.

Decision:

7. The State Executive Committee approved the recommendations of the Sub-Committee and release of funds to the concerned DDMA's/ Departments. The Chairman stated that when equipment is distributed in a blanket manner at many places they are not properly looked after. The proposal at Sr. No.6 and the amount against the proposal is agreed in principle, but the DM Cell must involve all stakeholders to ensure their commitment to the programme and roll out the scheme in a phased manner, depending on the felt need.

Agenda No. 26.4 Proposal for Establishment of State Disaster Relief Reserve (SDRR) Store submitted by Director General – cum – Commandant General, HG, CD, FS & SDRF.

8. The SEC was apprised that in view of the alarming increase in the frequency and intensity of disasters in Himachal Pradesh recent years, there is an urgent need to strengthen the State's capacity for prompt and effective disaster response. The districts such as Mandi, Kullu, Shimla, and Kangra have been repeatedly and severely impacted by floods, cloudbursts, and landslides during recent monsoon seasons, resulting in widespread loss of life, destruction of property, and disruption of essential infrastructure. The Himachal Pradesh State Disaster Management Authority (HPSDMA) and corroborated by national disaster assessment agencies, highlight critical gaps in rapid logistics, pre-positioning of resources, and relief deployment mechanisms currently available with the State. There is, therefore, a pressing need to decentralize emergency resources and ensure swift, localized responses during emergencies.

9. Against this backdrop, the SDRF has proposed to establish a State Disaster Relief Reserve (SDRR) Store in line with the National Disaster Relief Reserve (NDRR) Store maintained by the National Disaster Response Force (NDRF). The primary objective of the SDRR Store will be to serve as a central repository of essential relief materials—such as tents, blankets, collapsible shelters, stretchers, emergency lighting equipment, water purification units, inflatable boats, and other critical emergency supplies—kept in a state of readiness for immediate deployment to disaster-affected areas. The SEC was further apprised that the SDRF has submitted preliminary proposal, and detailed proposal is still awaited. Kangra, Mandi, and Shimla districts are proposed as key locations for establishing SDRR Stores, considering their high disaster vulnerability and strategic geographical accessibility from various parts of the State. These centrally positioned districts will ensure swift dispatch of essential relief materials to severely affected areas during emergencies. Subsequently, additional stores may also be established in other vulnerable districts. Locating the store in Mandi will significantly improve the strategic reach, speed, and effectiveness of the State's disaster relief operations.

10. Such stores are needed to deal with frequent and large-scale disasters affecting large number of people at regular intervals. The SEC may consider to accord in-principle approval to the proposal of the SDRF.

Decision: -

11. The SEC examined the proposal of the SDRF and accorded in principle approval to the proposal in view of the nature of disasters the state is experiencing. The SDRF may submit detailed financial proposal with SOPs immediately.

Agenda No. 26.5 Ex-Post-Facto Approval for the funds of SDRF/NDRF utilized for removal of Debris from public places in district Mandi.

12. It was brought to the notice of the SEC that the Deputy Commissioner, Mandi had reported that a cloudburst and flash floods occurred during the night of 30th June to 1st July 2025, causing widespread devastation across various areas of Gohar and Thunag Sub-Divisions. The calamity led to loss of lives, damage to public infrastructure and private property, and blockage of roads. In response to this, DDMA Mandi issued directions to the SDM Thunag to carry out a site inspection in collaboration with the HPPWD Division, Seraj to assess the scale of debris accumulation and prepare estimates for clearance operations. The estimate for the removal of debris was submitted to the DDMA by the respective Sub-Divisions which was as below: -

13. The SEC was further apprised that the Deputy Commissioner, Mandi, requested for necessary approval and financial assistance from the State Executive Committee as per the provisions of the latest list of items and norms for assistance issued by the MHA, GoI vide letter No. 33-03/2020-NDM-I dated 11th July 2023. Under Item No. 4 (a) pertaining to **Clearance of debris in Public Areas** contained that assistance can be "As per actual cost, for a period up to 30 days from the date of start of the work, based on assessment of need by SEC for the assistance to be provided under SDRF and as per the assessment of the Central team for assistance to be provided under NDRF". In view of urgent nature of works, upon receipt of the proposal from the Deputy Commissioner Mandi, after getting approval from the chairman, State Executive Committee, the Department of Revenue, Disaster Management Cell has issued instruction to the Deputy Commissioner, Mandi to utilize the funds released to them under Cash Dole Head from SDRF/NDRF for the removal of debris from public areas. The matter was placed for ex-post-factor approval of the SEC. Besides, in view of the urgent nature of debris removal from public areas, there is need to empower all the DDMA's in this regard

Decision: -

14. The SEC accorded ex-post-facto approval to the proposal of the Deputy Commissioner Mandi for removal of debris from public places as per the norms of assistance notified by the MHA. And also decided as under: -

- It was also approved that the DDMA's are empowered to act promptly on such matters in future disasters in accordance with SDRF/NDMA norms.
- In view of the huge problem of muck in the state it was also decided to constitute a SEC Sub-Committee under the chairmanship of Secretary PWD to look into the matter and suggest action plan to scientifically deal with the issue. Nodal Officer (FCA) from Forest Department, Directors of Environment, Urban and Rural Development Departments and EnC PWD and JSV

shall be other members of the Committee. The Chairman may associate other technical personnel in the committee. The Sub Committee shall give its report within 45 days.

Agenda No. 26.6 Regarding construction of Disaster Relief Centres (Prefabricated Structures)

15. The SEC was apprised that the Deputy Commissioner, Mandi has submitted a proposal regarding construction of Disaster Relief Centers (Prefabricated Structures) in two different locations in Sub Division Thunag to house local residents who have been rendered houseless due to recent disaster:

16. The SEC was apprised that the Deputy Commissioner Mandi has proposed that the above Disaster Relief centres will serve as safe shelters during disasters/emergencies and will also be utilized for community purposes during normal times, thereby ensuring optimum use of resources. In view of the urgent nature of the work, approval to DC Mandi was conveyed after obtaining approval of the Chairman SEC vide letter no. Rev (DMC) (C) 2-1/2022-SDRF (2022-23Misc-II) dated 21.07.2025.

Decision: -

17. The SEC considered the matter and accorded the ex-post-facto approval for construction of temporary Prefabricated Structures (Disaster Relief centres) at different location proposed by the Deputy Commissioner Mandi.

Agenda No. 26.7 Requirement of Additional Funds for Retrofitting works under SDMF in District Sirmaur, H.P.

18. The SEC was informed that the SEC meeting in its 20th meeting vide Agenda No.20.5 approved the DPRs for retrofitting of schools and health institutions amounting to ₹40.25 crore with cost escalation, and directed that retrofitting may be executed through PWD, as the DM Cell has already trained around 50 engineers of PWD in retrofitting practices. As per the approval of SEC, funds amounting to ₹1434.90 lakh were sanctioned to DC Sirmour for retrofitting of 5 Senior Secondary Schools and 5 CHCs. SEC

was further apprised that the Implementing Agency (PWD) observed the necessity of additional civil works on account of non-consideration of damaged doors and windows that require retrofitting, realistic electrical estimates received from the PWD in place of the earlier 5% provision, non-inclusion of shifting of medical oxygen pipelines in hospital buildings, and applicability of 18% GST effective from July 2022. Funds are available under SDMF and an amount of Rs. 307.07 lakh may be sanctioned as additionality to DC Sirmour so that the works can be completed in a time-bound manner.

Decision: -

19. SEC approved an additional amount of Rs. 307.07 lakh under SDMF for the retrofitting works in District Sirmour so that the projects can be completed within the revised scope and timeline.

Agenda Item No. 26.8 Submission of PPR under National Landslide Risk Mitigation Program Amounting to Rs. 139 Cr.

20. The Committee was informed that the NDMA has launched National Landslide Risk Mitigation Programme (NLRMP) and under its Phase-I the allocated funds for the State amounting Rs 139 Cr. The four districts namely Mandi, Shimla, Kinnaur, and Chamba have been selected under first phase of the NLRMP. In this context the about 37 most critical and highly prone landslide sites, as provided by the PWD have been chosen to be mitigated under this programme. The road in districts of Mandi, Shimla, Kinnaur, and Chamba of Himachal Pradesh are highly susceptible to landslides due to their rugged mountainous terrain, high seismic activity, and frequent heavy rainfall/snowfall. The steep slopes, fragile geological formations, and unregulated construction further exacerbate the risk of landslides, leading to loss of life, infrastructure damage, and disruption of connectivity. The SEC was apprised that the HPSDMA has prepared and submitted a PPR on Landslide Risk Mitigation in Himachal Pradesh worth amounting Rs 139 Cr on 02.04.2025 under the NLRMP to NDMA after taking the approval of the Chief Secretary-cum-Chairman SEC. Further the proposal has been discussed in the TAC held on 08.04.2025 conducted by NDMA. Further, the Preliminary Project Report (PPR) was reviewed and approved in the 9th meeting of the State Disaster Management Authority (SDMA) at Agenda Item No. 9.5 held on 07.07.2025, wherein it was directed to submit the proposal for funding. The Finance Department, GoHP, has also conveyed its concurrence for 10% state share. The matter regarding submission of PPR to NDMA is placed for ex-post facto approval of the SEC.

Decision: -

21. The SEC accorded ex-post-facto approval for submission of the Rs. 139 crore PPR under NLRMP to NDMA.

Agenda Item No. 26.9 Submission of PPR under Mitigation Scheme for Forest Fire Risk Management (MSFFRI) through National Disaster Mitigation Fund (NDMF) for Himachal Pradesh worth Rs.8.16 Crores.

22. The SEC was informed that the Forest Department, Himachal Pradesh has prepared a Preliminary Project Report (PPR) under the *Mitigation Scheme for Forest Fire Risk Management (MSFFRM)* amounting to ₹8.16 crore (₹7.42 crore NDMA share + ₹0.74 crore State share) for 2025–26. The project covers three highly fire-prone districts Bilaspur, Mandi, and Sirmaur with ₹4.39 crore, and the remaining ₹3.77 crore for other districts. The scheme aims to reduce forest fire frequency and intensity, enhance early detection and response, involve communities, and restore ecosystems through interventions such as fuel load reduction, fire breaks, early warning systems, training, and awareness campaigns. The proposal was submitted to NDMA on 26.05.25 after taking the approval of the Chief Secretary-cum-Chairman SEC. The matter has been submitted to the Finance Department, GoHP, for concurrence regarding the 10% State share. The matter regarding submission of PPR to NDMA is placed for ex-post facto approval of the SEC.

Decision: -

23. The SEC accorded ex-post-facto approval for submission of the Rs. 8.16 crore PPR under Mitigation Scheme for Forest Fire Risk Management to NDMA.

Agenda Item No.26.10Approval of proposals recommended by 6th TAC under State/National Disaster Risk Mitigation Projects

24. The State Executive Committee was briefed that the state of Himachal is prone to various hazards, both natural and manmade. In order to mitigate impact of various hazards which affect the State, under the DM Act, 2005, State Disaster Response Fund (SDRF) and State Mitigation Fund (SDMF) have been notified. The NDMA Division of MHA has notified guidelines on 6th March 2023 to administer these funds. The DM Cell has also notified Project Appraisal Committee (PAC) and Technical Advisory Committee (TAC) in accordance with SDMF guidelines. According to the provisions of the 15th Finance Commission, a total of ₹501.60 crore (approx.) has been allocated under the State Disaster Mitigation Fund (SDMF) for the period from FY 2021-22 to 2025-26. Additionally, the Himachal Pradesh State Disaster Management Authority (HPSDMA) has made the provision and allocated approx. ₹90.80 crore (approx.) to address various hazards. Thus, the total fund provision under SDMF for the FY 2020-21 and 15th FC (FY 2021-22 to 2025-26) ₹592.4 crore (approx.), out of this, 366 proposals have been approved by SEC in its various meeting, amounting to 738.09 Cr (approx.). Till date, 378.79 Cr. (approx.) funds have been released to various organizations, while 359.29 Cr.(approx.) still need to be released to the various Implementing Agencies (IAs).

25. That the SEC was apprised that as on date, the availability of funds with the Disaster Management Cell (DMC) under the State Disaster Mitigation Fund (SDMF) stands at ₹97,92,98,586. This includes an opening balance of ₹48,22,82,068 as on 01.04.2025, along with an additional receipt of ₹55,20,00,000 during FY 2025-26. Further, the total funds available under SDMF amount to ₹97,92,98,586. In addition, 2nd instalment of SDMF amounting to ₹ 55,20,00,000 will be released in December 2025. In its 6th meeting held on 06th September 2025, the TAC reviewed 22 project proposals. Out of these, 8 proposals were approved, 5 were approved in principle, and 6 were not recommended by the Committee. In addition, one proposal regarding the EWS for 48 sites had already been approved by the SEC in its 25th meeting. The district-wise and hazard-wise details are as follows:

26. That the current availability of funds during the current FY under SDRF is around Rs. 153.12 Cr. That the IAs have submitted revised 2 DPRs of the proposal recommended under NDMF to the PMU. It was proposed to the SEC that

- I. The SEC may accord approval to sanction 8 No of projects amounting to ₹ 24,72,86,889. Funds may be released subject to availability and adhering to 50% ceiling to mitigate single hazard.
- II. 5 No. of proposals (SDMF) may also be approved subject to submission of revised DPRs.
- III. 2 No. of proposals under NDRF may approved to be sent to NDMA. Concurrent of FD may also be processed parallelly.

Decision: -

27. The SEC as discussion and consideration approved as under: -

- I. The SEC accorded approval to sanction 8 No of projects amounting to ₹ 24,72,86,889. Funds may be released subject to availability and adhering to 50% ceiling to mitigate single hazard.
- II. 5 No. of proposals SDMF) be approved subject to submission of revised DPRs.
- III. 2 No. of proposals under NDRF approved to be sent to NDMA. Concurrent of FD may also be processed parallelly.
- IV. The SEC also accorded in-principle approval to an important mitigation project of Solan district namely, "Landslide Mitigation below IHSDP Flats in Sector 5 Parwanoo, Solan. The same may be sanctioned after approval of DPR front TAC.

Agenda Item No. 26.11: Approval for 5% Annual Increase in Consultancy Fee of Three DSS Consultants Serving in DDMA's under NIELIT w.e.f. 01.04.2025

28. The SEC was apprised that the Department of Revenue (DM Cell) hired services 28 Consultants under Development Support Staff (DSS) Project through UNDP India. These consultants were posted in all the DDMA's of Himachal Pradesh. Out of these 28 consultants, at present only 3 Consultants are serving in the DDMA's and their services have been hired through NIELIT. In the 9th Meeting of the State Executive Committee, it was approved that 5% annual increase will be given to the Consultancy Fee of these consultants. The annual increase of 5% in consultancy fee of these three consultants is due from 01-04-2025. The annual liability of 5% hike to these consultants will be 62,412/- and this can be met from Preparedness and Capacity Building Window of SDRF.

Decision: -

29. The SEC approved a 5% annual increase in the consultancy fee of the three DSS consultants posted in the DDMA's under NIELIT, effective from 01.04.2025. The additional expenditure (₹62,412 annually) will be met from the Preparedness & Capacity Building window of SDRF.

Agenda Item No. 26.12: Approval of Preliminary Project Report for READY-HP

30. It was brought to the notice of the SEC that the State of Himachal Pradesh witnessed huge damage/losses during Monsoon 2023 disaster. The total damages/losses were estimated at Rs 9906 Crore. The State Government in collaboration with NDMA also conducted the Post Disaster Needs Assessment which was assessed at Rs 9042 Crore. The Finance Minister, Government of India, in the Budget Speech on 23-07-2024 made the following Budget announcement for the State of H.P.

“Himachal Pradesh suffered extensive losses due to floods last year. Our government will provide assistance to the state for reconstruction and rehabilitation through multilateral development assistance.”

31. Further, the Department of Expenditure in July 2025 conveyed to the Department of Economic Affairs, GOI that in view of the Budget announcement of the 2024-25 and extensive damages caused in the State of Himachal Pradesh due to floods And cloudburst in FY 2023-24, the EAP Ceiling for the State of H.P. for loan approval/signing of loan agreement for EAP Projects for the period from 2023-24 to FY 2025-26 is enhanced by 2,150 Crore so as to accommodate the aforesaid project submitted by the GoHP. The DM-Cell after approval of the State Level Screening Committee, submitted the Preliminary Project Report to the DEA on 13-08-2025. The World Bank Mission has visited the State three times to finalise the Program Appraisal Document under HP-READY Project and has held many rounds of discussions with the Departments. The Project will only cover the assets damaged from the year 2023 to 2025.

32. That the proposed project **“Resilient Action for Development and Disaster Recovery Himachal Pradesh (READY-HP)”** is to be implemented by the Revenue Department–Disaster Management Cell, Himachal Pradesh, with financial assistance from the World Bank (80%) and the State Government (20%). The project, scheduled from January 2026 to November 2030, with a total cost of ₹2687.5 crore (USD 312.5 million), aims to support resilient disaster recovery and enhance state capacities for climate-resilient development. Its key focus areas include reconstruction and strengthening of critical infrastructure such as roads, bridges, public buildings, irrigation schemes, and renewable energy systems; rehabilitation of livelihoods with emphasis on tourism and allied sectors; and capacity building in disaster risk management through flood hazard zonation, land-use planning, building regulation, and disaster risk financing. The expected outcomes include enhanced resilience of communities and infrastructure, establishment of effective early warning systems, slope and flood protection measures, and the rollout of innovative disaster risk financing;/ instruments. The project also integrates climate adaptation, gender sensitivity, community participation, and private sector engagement, while aligning with SDGs 8, 9, 11, and 13.

Decision: -

33. The SEC took note of the action taken.

Additional Agenda Item

Agenda Item No. 26.13: Order Issued by the DM Cell Under Section 24 of the Disaster Management Act, 2005.

34. The monsoon season started in the State from 19th June 2025 and the State has experienced large-scale damage and losses during different heavy spells of rains i.e. 26th June in Dharamshala and Kullu; 30th June and 01 July in various parts of the Mandi district; 5-6 and 13-14 August across the entire state; 24-26 August in Chamba, Kullu and Lahaul & Spiti districts. In Chamba district due to Mani Mahesh Yatra many yatris got stranded along the yatra route and between Chamba and Bharmour due to disruption of road connectivity. Keeping in view widespread damage of infrastructure and loss of precious lives, the Chairman of the State Executive Committee on 01st September, 2025 issued an order under Section 24 of the DM Act, 2005. In this order it was mandated that: -

- i) All the Departments of the State shall ensure that the Emergency Support Functions (ESFs) notified vide order Rev.(DMC-C)20-2/2020-COVID19 dated 26th March 2024 by the SEC are strictly adhered to and necessary actions taken by all concerned to ensure prompt action for emergency response.
- ii) The District Magistrate may issue all necessary orders under section 34 of the Act, which authorizes them to do so in the event of a threatening disaster situation.
- iii) The PWD, JSV and HPSEBL shall take adequate measures to ensure restoration of their respective services on war footing.
- iv) All the Departments and DDMA's of the State shall take all measures required to ensure smooth movement of people, goods and services within their respective jurisdiction.
- v) All the DDMA's shall ensure that relief measures are taken timely to provide relief to the affected people.
- vi) All the Telecom Services Providers shall ensure that mobile and landline connectivity is restored and maintained on war footing across the State.
- vii) All the Local Authorities (PRIs and ULBs) shall take all measures for emergency response, restoration and relief in the affected areas and render necessary assistance to the DDMA's and Departments of the State.

Decision: -

35. The SEC ratified the Order issued by the Chief Secretary cum Chairmanship SEC issued on 01-09-2025.
