

Proceedings of the Committee meeting for Hiring of PMDC Services under HPDRRP, under the Chairmanship of Sh. Nishant Thakur, Program Director, held on dated 12th August 2025 at 11:00 AM

The technical evaluation meetings for hiring of PMDC consulting services submitted by eight firms were conducted from 4th August 2025 onwards and concluded on 12th August 2025. During these meetings, the Committee members reviewed each RFP in accordance with the terms outlined in the RFP document and its subsequent corrigendum. Based on a detailed evaluation, the following firm(s) have been recommended by the Committee, for opening of financial bids:

The financial bids will open on 14th August 2025 at 11:00 AM.

During the meeting, it was discussed that at the initial stage, score for GIS expert was not included in the RFP document (PMDC) and HP e-tendersportal. Subsequently, a corrigendum-2/2025 was issued vide No. Rev(DMC)(F)11-50/2023-DRRP(AFD-III)(PMDC-AFD) dated 09th July 2025 to also include score for GIS expert. However, at that stage HP e-tenders portal does not allow to update the section w.r.t. addition of any other field (*read: GIS expert*) on the portal.


Due to the unavailability of the corresponding field in the HP e-tenders portal (hptender.hp.gov.in), marks for the GIS Expert could not be entered online as the portal does not allow any modifications to the tender evaluation sheet under the QCBS method, once it has been floated on the portal. Therefore, the marks for the GIS Expert have been added in the point: **3.4 Approach, Methodology & Work Plan.**{For E.x. 18(Approach, Methodology &

Work Plan.)+3 (GIS Expert)} ,and the total score in this field is *inclusive* of score awarded for GIS Expert.

The maximum scores on *HP e-tenders portal* for Team leader, Environmental Specialist, Social and Gender Specialist, Climate resilient Structure Specialist may be read as; 9, 4, 4 and 4 respectively and the Maximum score for GIS Expert would be 4, and the rest categories of experts would have the same maximum score, as before as per this corrigendum, based on which marks have been awarded on *tender evaluation sheet* online.

The Committee decided that due to this limitation of the HP e-tenders portal, the detailed marks may be given offline, and the proceedings of the same, which includes marks awarded to all participants (successful/ unsuccessful) shall be uploaded on the HP e-tenders portal along with a copy on the HPSDMA website.


The *detailed technical scores* of all *participating firm(s)* are enclosed at **Annexure "A"**.


Note: This clarification has been given to enable this Office to upload technical scores on the HP e-tenders portal, since only after the Technical scores are uploaded on it will the Portal allow the opening of the Financials bids, online.


