At the outset, the Principal Secretary (Revenue), welcomed the Chief Secretary, the Members of the SEC and other participants. He briefly apprised the SEC about the financial management for Disaster Management under the 15th Finance Commission i.e. State Disaster Risk Management Fund (SDRMF) which is further bifurcated into 80% of State Disaster Response Fund (SDRF) and 20% of State Disaster Mitigation Fund (SDMF). He also shared that the final Guidelines for administration of SDMF and the 20% funds for the Financial Year are still awaited from the Government of India, however the SDMA has notified state guidelines for SDMF on 8th June 2020 and projects are being executed according to these guidelines for the SDMF of FY 2020-21.

Thereafter Sh. Sudesh Kumar Mokhta, Director-cum-Special Secretary (Rev-DM) initiated with a presentation and took up agenda items for discussions. The presentation was divided into following parts:

- 1. Status of the projects approved by the SEC in its 14th meeting dated 5th August 2020 for which the funds have already been disbursed.
- 2. The projects approved by the SEC in its 15th meeting dated 22nd March 2021 for which funds are still to be released and reconsideration for these projects was required by SEC before disbursement of funds.
- 3. New proposals received by the Disaster Management Cell for consideration and funding under SDMF.

Directions by the Chair:

- 1. All the Deputy Commissioners shall refer to the SDMF guidelines and prepare eligible project proposals under SDMF. The SDMF shall be distributed to the districts & departments rationally.
- 2. The Projects shall also focus on the earthquake/landslide and other local hazard specific mitigation projects prioritizing the mitigation of hospitals and schools.
- 3. The district specific projects from any agency/institution/organisation shall be forwarded through the respective Deputy Commissioner only, with the endorsement and vetting from the DDMA.
- 4. The Secretary (JSV) shall re-access and evaluate the proposals submitted by Jal Shakti Vibhag under SDMF and prioritize the proposals under permissible activities as per the guidelines of SDMF.



- 5. The Engineer-in-Chief, HPPWD shall vet the landslide mitigation related projects at the state level for projects costing more than Rs. 2.5 crores. Other than the Landslide mitigation PWD shall submit revised proposals for snow blowers, bailey bridges etc and road safety.
- 6. The landslide mitigation projects shall be sent in NDMA's Landslide Mitigation DPR template.
- 7. The projects being posed by the DDMAs shall be focussed on the disaster criticality and HRVA of the district.
- 8. The proposals shall be scrutinized by the Technical Evaluation Committee (TEC) appointed by the DM Cell and prioritization may be done before placing the proposals to SEC.
