Subject: Formation of the School Safety Advisory Committee at the State Level.

The National Disaster Management Authority (NDMA), Government of India has formulated National Disaster Management Guidelines – School Safety Policy 2016 under the provision of Section 6 (1) of the Disaster Management Act 2005 with a vision of India where all children and their teachers, and other stakeholders in the school community are safe from any kind of risks due to natural hazards or otherwise. All the requirements to ensure safety of children in schools mentioned in the said Policy are statutory in nature and everyone involved in the process of ensuring safety of children are statutorily bound by the same.

The Hon'ble Supreme Court, vide its order dated 14th August 2017 in W.P. No. 483 of 2004 has directed that the School Safety Policy issued by NDMA have to be implemented in letter and spirit by all concerned authorities. As per the Section 5.2 (iii) of the policy guidelines a School Safety Advisory Committee has to be formed at the State level for successful implementation of the School Safety Policy Guidelines in the State.
