

NARRATIVE REPORT- URR

MAIN RESULT AREA I: INSTITUTIONAL STRENGTHENING

- Formation and meetings of the District/City Disaster Management Authority, Inter agency groups (GO-NGO) and expert/ thematic groups especially related to urban management
- Development of HR strategy for DM by local government (Municipality/ Corporation)
- Assess the training requirements of the urban institutions involved in Disaster Management trainings
- Workshop/consultation meetings to review/update the city plans
- Workshop/consultation meetings with various city level agencies to develop Standard Operating Procedures
- EOC strengthening
- Strengthening of Emergency Support Functions (ESF) for effective response and introduction of Incident Command System (ICS)

MAIN RESULT AREA II: CAPACITY BUILDING

- Assess the training requirements of the personnel's involved in Disaster Management in the city
- Development of Capacity Building Plan for the city
- Training of key personnel like Engineers, Architects, Doctors on issues related to Disaster Risk Reduction in urban areas especially on building bye laws, safe construction practices, etc
- Training programmes for Mayors, City councilors and Ward Members on CBDRR
- Training of Education department officials, school teachers, students and parents on school safety initiatives
- Trainings on safe construction practices for the cutting edge construction fraternity i.e. masons, bar-benders, carpenters, etc..
- Training on preparation of inclusive disaster management plans at city and ward levels

MAIN RESULT AREA III: MAINSTREAMING FOR DEVELOPEMENT

- National level advocacy workshops on mainstreaming DRR in JNNURM and RGAY
- Workshops (Agency selection process) for Hazard Risk and Vulnerability Assessment
- Activities undertaken for mainstreaming- training module on DM inclusion in SSA, AWW, Police, PWD, education etc or design change of school/hospital/ private buildings or introduction of insurance schemes in housing, agriculture, animal husbandry as part of ongoing programmes
- Using Risk assessments for preparation of urban master plans

- Development of national models, tools and guidelines by developing Model amendments, bye laws and guidelines
- Review, updating and application of Building codes and development control rules at the municipal level
- Workshop/Consultation/Study undertaken to strengthen enforcement of building codes, by-laws and development control regulations and aim to facilitate introduction of regulatory changes for enforcement of building by-laws and codes.
