The committee will cover all issues related to the Disaster Management and Disaster Risk Reduction in the State of Himachal Pradesh with special focus on:-

1. Preparation of inter Sectorial strategies required to address the issues DRR in the State.
2. Formulation of Action Plan to:-
 - a) Strengthening of Disaster Management in the State of HP

- b) Prepare hazard-specific and sector-specific action plans to reduce existing disaster risks and prevent future disasters risk.
- c) Suggestion for improving Early Warning and Response Capacity of various Stakeholders.
- d) Strengthening of Capacity Building of various Stakeholders.
- e) Any other measure that would be required to drive or transform Disaster Risk Reduction in the State.

The Advisory Committee should hold office for a period of one year. The first Interim Report of advisory committee must be submitted by the end of March 2024. The Advisory Committee shall advise the HPSDMA through CEO, SDMA-cum-Chief Secretary in any other matter which may be of immediate concern or relevance to the State. The secretariat assistance to the advisory committee shall be provided by the DM-Cell, Department of Revenue. The members of the Advisory Committee shall be provided honorarium, TA/DA, etc. as per the provisions of Rule 4 of Himachal Pradesh State Disaster Management Rules, 2011.
